

First Brazilian Think Tanks Summit: Challenges and Perspectives facing Brazilian Think Tanks

Objective

The **Brazilian Center for International Relations – CEBRI** is an independent think tank that contributes to the public debate on the main challenges facing Brazil at the international level. Over the last twenty one years, the institution has engaged in promoting plural and action-oriented debate on the international landscape and Brazilian foreign policy. CEBRI focuses not only on providing a venue for high-level discussions, but also on putting forward recommendations that can have an impact on public policies in areas with the greatest potential to leverage the international projection of Brazil onto the global order.

In the context of the 2020 Global Think Tank Summit and Forum Program, CEBRI is organizing a conference about the “**Challenges and Perspectives facing Brazilian Think Tanks**” in partnership with the **Think Tanks and Civil Societies Program (TTCSP) of the University of Pennsylvania**, the institution responsible for elaborating the Global Go To Think Tank Index Report.

The event will gather Brazilian think tanks in Rio de Janeiro in order to contribute to the establishment of a local network of think tanks and to enhance the debate on key issues related to policy and organizational challenges that these institutions are facing or may face in the present and in the years to come. It will be an opportunity to share experiences and discuss strategies to strengthen the role of think tanks in Brazil.

The Think Tanks Dialogue will be composed by a diverse set of panelists, taking into account think tanks’ thematic agendas and categories (independent, government affiliated, university affiliated, for-profit public policy research organization etc.) in order to cover a wide range of opinions, experiences and best practices.
